Radiation Protection (Registration of Radiation Sources and Facilities) Regulations 2009

RADIATION PROTECTION ACT

Regulations made by the Minister under section 24 of the Radiation Protection Act

- 1. These regulations may be cited as the Radiation Protection (Registration of Radiation Sources and Facilities) Regulations 2009.
- 2. In these regulations -

"Act" means the Radiation Protection Act;

"applicant" means a person making an application under regulation 3 or 4;

"certificate of registration" means a certificate issued by the Authority under regulation 7;

"facility" means any place where a source is being used or stored, except a place where a source is being temporarily used or stored.

- **3.** Every owner of a sealed source or radiation generator, shall apply for its registration to the Authority within 30 days of the date of acquisition of that sealed source or radiation generator.
- **4.** Every owner of a facility shall apply for registration of that facility within 30 days of the date on which the facility becomes operational.
- 5. Every application for the registration of a sealed source, a radiation generator or a facility shall be -
 - (a) submitted to the Chief Radiation Protection Officer in such form and in such manner as may be determined by the Authority; and
 - (b) accompanied by the appropriate non-refundable fee specified in the Schedule.
- **6.** The Chief Radiation Protection Officer may, on receipt of an application under regulation 3 or 4, require the applicant to submit such additional information as may be necessary in support of the application.

- 7. (1) The Authority may grant or refuse an application made under regulation 3 or 4.
 - (2) Where the Authority grants an application under paragraph (1), it shall issue a certificate of registration to the applicant in such form as may be approved by it, subject to such terms and conditions as it thinks fit.
 - (3) A certificate issued under paragraph (2) shall not be transferable.
- 8. (1) Every person who is in possession of a sealed source or a radiation generator, at the coming into operation of these regulations, shall, within 3 months of the date of coming into operation of these regulations, submit an application for the registration of that sealed source or radiation generator to the Chief Radiation Protection Officer.
 - (2) Every owner of a facility which is in operation at the time of the coming into operation of these regulations shall, within 3 months of the date of coming into operation of these regulations, submit an application for the registration of that facility to the Chief Radiation Protection Officer.
- **9.** Every person who fails to comply with these regulations shall commit an offence and shall, on conviction, be liable to a fine not exceeding 10,000 rupees and to imprisonment for a term not exceeding 6 months.
- **10.** These regulations shall come into operation on 16 November 2009. Made by the Minister on 21 October 2009.
