Relations (Trade Union) Regulations 2009

THE EMPLOYMENT RELATIONS ACT 2008

Regulations made by the Minister under section 106 of the Employment Relations Act 2008

- 1. These regulations may be cited as the **Employment Relations (Trade Union) Regulations** 2009.
- 2. In these regulations -

"Act" means the Employment Relations Act 2008.

- **3.** (a) Where a trade union is to be wound up under sections 5(11) and 7(9) of the Act, the Registrar shall publish in the *Gazette* and in 2 daily newspapers a notice showing -
 - (i) that the trade union is being wound up;
 - (ii) that its property is vested in the Registrar; and
 - (iii) the last day for lodging any claim upon the property of the trade union.
 - (b) Upon the publication of the notice in the *Gazette*, all property of the trade union shall vest in the Registrar who shall use the property to pay, as far as possible, all the debts of the trade union and the expenses of the winding up.
 - (c) Any remaining property of the trade union, after payment of all the debts and the expenses of the winding up, shall vest in the State.
- **4.** (a) Any interested person may, on a written application to the Registrar and on payment of the fee specified in regulation 6, inspect the register of trade unions.
 - (b) Any interested party may, on an application to the Registrar and on payment of the fee specified in regulation 6, obtain a copy of the returns of a trade union.

- 5. (a) Every trade union shall keep -
 - (i) a book of accounts showing its receipts and payments and documents in support of such receipts and payments;
 - (ii) the membership application form signed by the member showing the member's name, address, occupation (if applicable), employer's name and. date of birth (if applicable);
 - (iii) minutes of proceedings of all meetings in chronological order signed by the President and Secretary;
 - (iv) record of attendance of members at all meetings showing the date of the meeting, the member's name and signature;
 - (v) a register of assets showing the date of acquisition and cost of the asset.
- 6. The fees specified in the Schedule shall be payable for the purpose of the Act and of these regulations.
- 7. The Trade Union Regulations 1974 are revoked.
- 8. These regulations shall come into operation on 2 February 2009.
